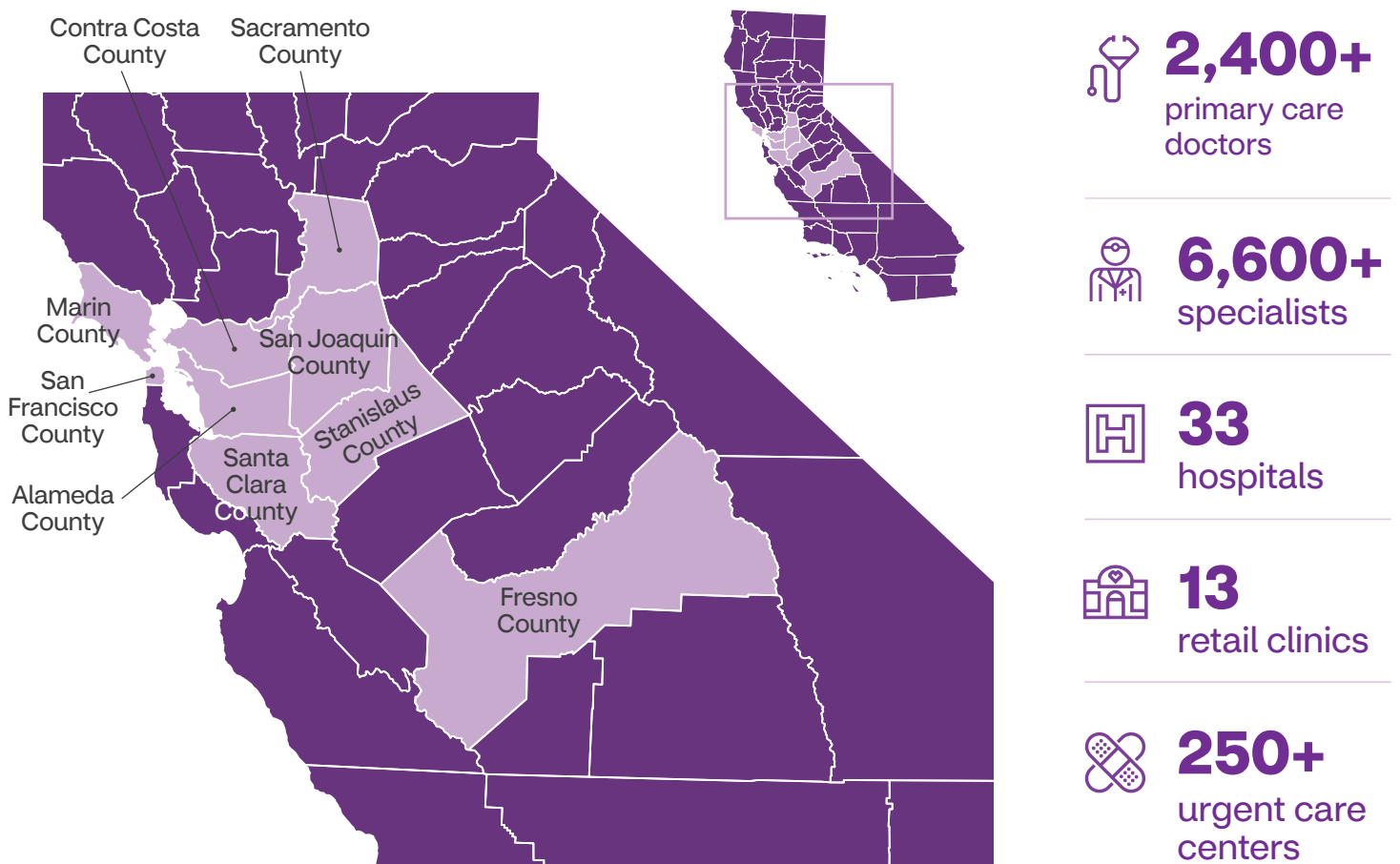

Aetna Whole Health Northern California HMO network coverage**

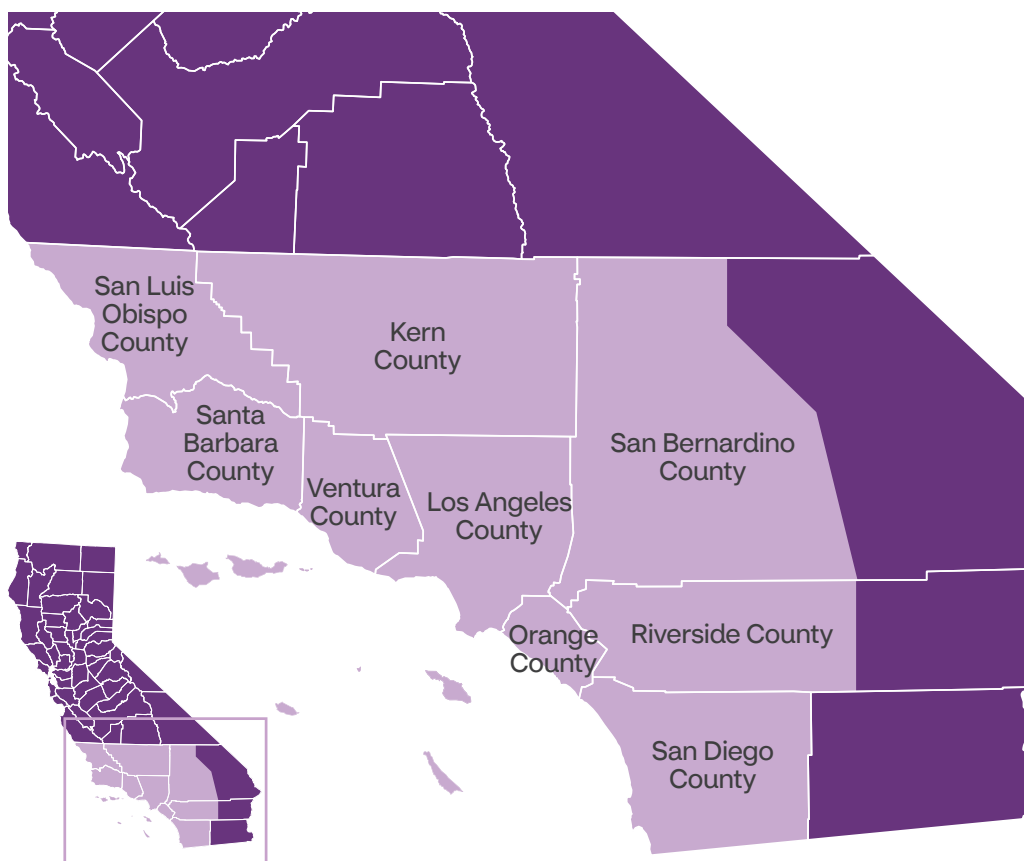
